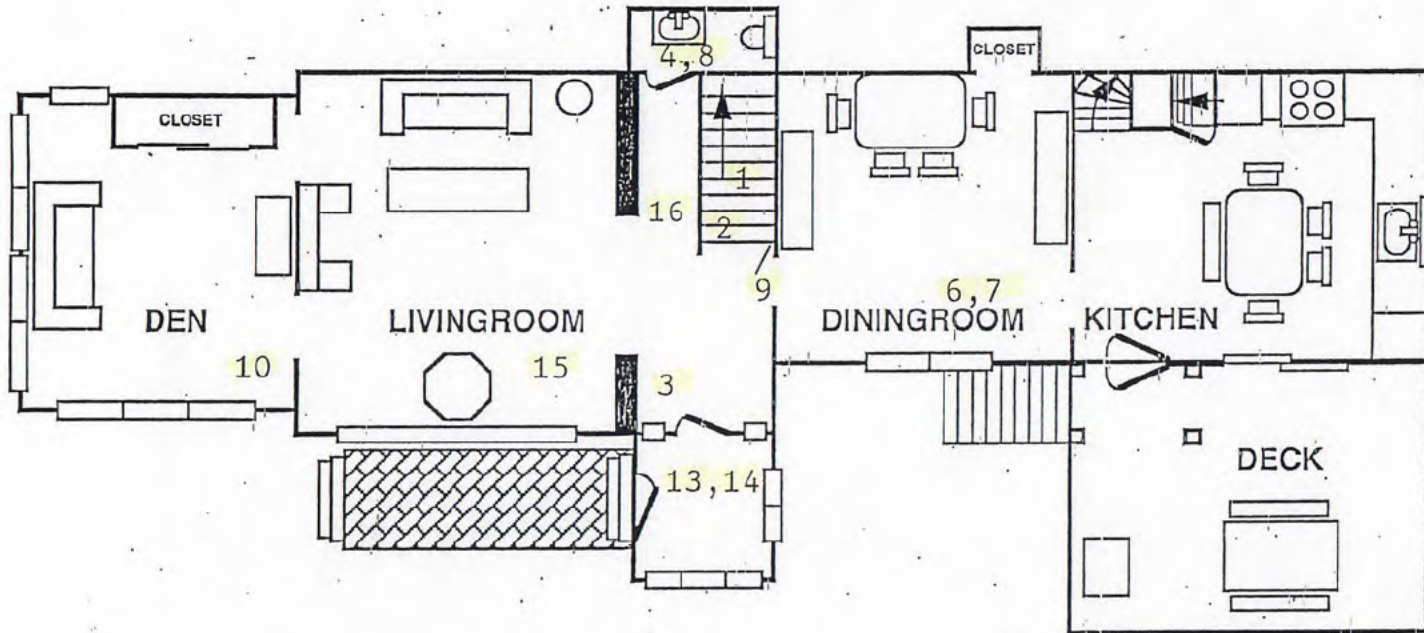


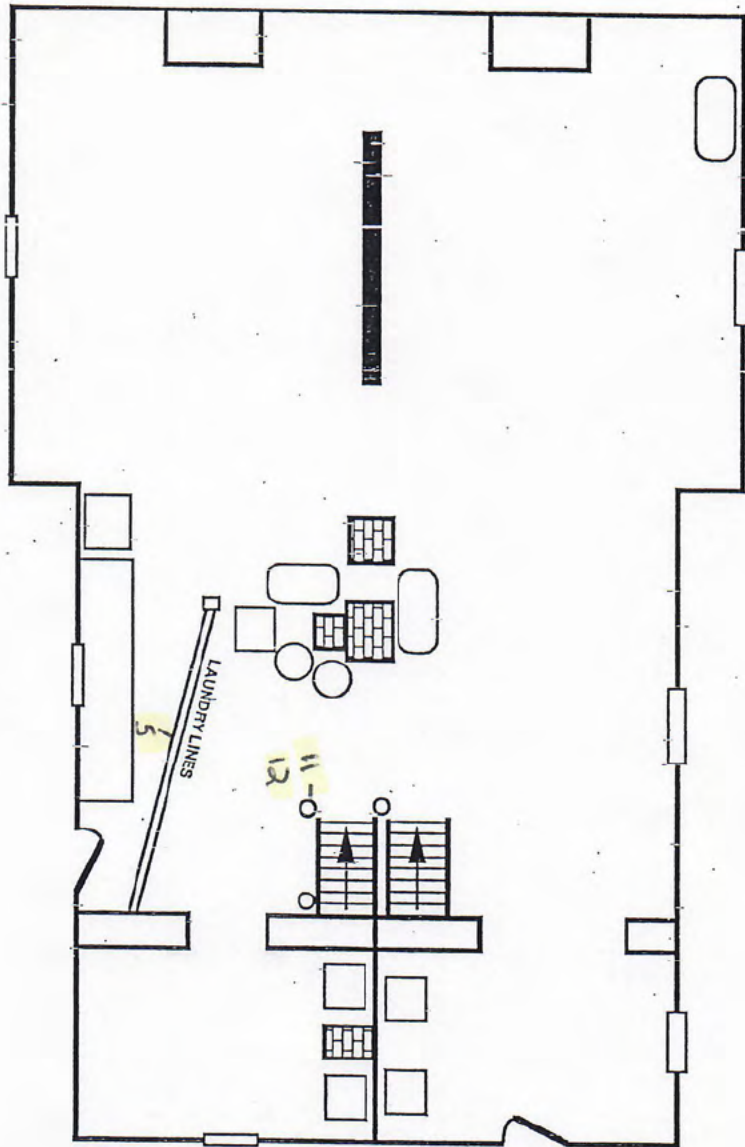
1. Neighbors Reckley and Flint hear loud banging noise on stairwell at 8:15 pm.

RE: Afternoon Membership Meeting Request

Dear Superintendent Divris,

We are writing to you requesting an afternoon meeting time for the members of EGL who cannot attend night meetings. We attempted this request with DOT Boutwell but he denied this request for arbitrary reasons.

We believe that the termination of all afternoon membership meetings is discriminating against the disabilities (Mentally and/or Physically) of our membership.

Numerous members have informed the Mentor Board that they would not be able to attend a 6:00 - 8:00 pm membership meeting due to the necessity of receiving their medication. Medication dispense time can start as early as 6:40 pm.

Under 103 DOC 473 Inmate Self-Improvement Groups, it states:

473.02 (1) "Inmate Self-Improvement Group membership shall not discriminate or mistreat inmates on the basis of actual or perceived... age... disability... ."

Some of the members are now given the choice of either receiving their medication or being a member of the EGL program. At least 6 members are in the Residential Treatment Unit (RTU), another 5-10 informed us they receive life saving medication, and another 5-8 informed us that they cannot hear us at the meetings in the new gym because of their hearing loss (ADA) and the echoing in the gym.

When you and former DOT Kerry Keefe used to attend our Board meetings, we worked out a schedule that made sure the needs of the membership were being met. We agreed to hold afternoon meetings for the members who were disabled, members who worked at night, and members who have other schooling or programs at night. We made sure not to "discriminate or mistreat inmates".

Bob Boutwell has never attended a membership meeting. He wouldn't know the needs of the group. He is making these decisions of cancelling meeting times based on other reasons and not need.

What we are requesting is: allow us to continue our afternoon meetings for EGL members in the new meeting space in the library back room on either wednesday, thursday, or friday afternoons from 1:00 - 2:30 pm, similar to how the Veterans group have been allowed to meet in that back room. The room is unoccupied on thses aforementioned days and times.

This solution would allow us not to "discriminate or mistreat inmates on the basis of actual or perceived... age... disability..." In addition, we would not be using any existing or occupied room space and there would not be any need to staff this area as it is already staffed.

We look forward to hearing back from you on this important matter.
